

## **“OI & GVP Coloring for Troops” Coloring Contest**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

### **OFFICIAL RULES**

**1. Eligibility:** This Contest is open to legal residents of Mesa County, Colorado, who enter the Contest as a parent or legal guardian on behalf of a child whose age is thirteen (13) years or younger at the time of entry.

Employees of Grand Valley Power, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

**4. How to Enter:** The Contestant must print and mail or drop off in-person, a completed entry form and approved coloring page provided by Grand Valley Power,

which can be found at [gvp.org/hometown-partnerships](http://gvp.org/hometown-partnerships) or on Grand Valley Power's Facebook page <https://www.facebook.com/GVRuralPower/>. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Each qualified entry form and coloring page will equal an entry to win. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Grand Valley Power. A household can only win once through the duration of the Contest. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Grand Valley Power.

**5. If Winner cannot be contacted, is ineligible, fails to claim the

prize within (2) two business days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate Winner selected.
